STR hosted three student conferences - Orange County, California with over 2,200 attendees, Dallas, Texas with over 1,500 attendees, and Birmingham, Alabama with over 1,500 attendees. STR had 52 radio broadcasts, and 178 podcast episodes were downloaded nearly one million times from 166 countries. Over a million visits were made to STR's website, and our email subscriber list grew to over 45,000 people. Over 20,000 individual training resources were distributed (CDs, MP3s, DVD, books, and PDFs).
